Federal	Demonstration Grants for Indian Children http://www.ed.gov/programs/india ndemo/index.html	The absolute funding priorities for the program limit project services to: (1) school readiness projects that provide age appropriate educational programs and language skills to three- and four-year-old Indian students to prepare them for successful entry into school at the kindergarten level; and (2) college preparatory programs for secondary school students designed to increase competency and skills in challenging subject matter, including mathematics and science, to enable Indian students to transition to postsecondary education.

Teen parents and their children from birth through age 7 also are eligible. All participating families must be those most in need of program services.

Expenditures must follow the guidelines set out for IDEA.

By enhancing professional development, performance goals, state assessments, programs and materials, integrated use of technology, and specialized personnel (social workers, psychologists, and physical therapists), IDEA-Part B promotes an equal opportunity at education for students with disabilities.

Funds support increased professional development to ensure that all teachers have the skills they need to teach these programs effectively. The program also supports the use of screening and diagnostic tools and classroom-based instructional reading assessments to measure how well students are reading and to monitor their progress.

Title I, Part A also encourages parental involvement in their child's education.
